SUMMARY ANNUAL REPORT FOR GLAZIERS, ARCHITECTURAL METAL & GLASS WORKERS LOCAL UNION #1399 HEALTH & WELFARE TRUST

This is a summary of the annual report of the Glaziers, Architectural Metal & Glass Workers Local Union #1399 Health & Welfare Trust, E.I.N. 33-0432608, Plan No. 501, for the year ended August 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan Inc, Delta Dental of California and The Union Labor Life Insurance Company to provide certain medical, hospital, dental, life and accidental death & dismemberment benefits incurred under the terms of the plan. The total premiums paid for the plan year ended August 31, 2020 was \$3,307,894.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$10,667,978 as of August 31, 2020, compared to \$10,524,311 as of September 1, 2019. During the plan year, the plan experienced an increase in its net assets of \$143,667. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$4,930,827 including employer contributions of \$4,208,151, participant contributions of \$62,406 and earnings from investments of \$660,270.

Plan expenses were \$4,787,160. These expenses included \$228,507 in administrative expenses and \$4,558,653 in benefits paid to or for participants and beneficiaries.
